



PROTECTION OF PERSONAL DATA

What are we doing with your personal data?

You feel like you are one of those specialists we are looking for! So you apply and then we ask for your personal details. Then of course you want to know what will happen with these data. In this privacy policy, we explain which data we collect and what we do with this data.

What personal information do you collect from me?

When you apply through our website, we may collect the following personal data from you:

- First and last name;
- Date of birth;
- Phone number;
- E-mail address;
- C.V.;
- Motivation letter;
- Educations;
- Availability;
- Other personal data that you provide to us by e-mail or via the contact form.

Why do you collect my personal data?

The data you fill in on the (digital) application form and the website are processed exclusively by BookerZzz to determine whether you are eligible for a position within BookerZzz. The data will not be used in any other way and / or stored for other purposes. To make a good selection of applicants for the right vacancies, the recruitment and selection process at BookerZzz consists of comparing the data of the specialists with the vacancy (s) and the corresponding qualifications, contacting specialists for a further acquaintance and / or planning a job interview, possibly and if relevant contacting specified referees and / or training institutes and passing on information to applicants about other vacancies for which the applicant could be eligible.

The applicant's personal data will initially be collected by filling in the digital application form by the applicant. Personal data can then also be collected through personal and / or telephone contact with the applicant, referees and / or training institutes, or further written information.

With whom do you share my personal data?

The personal data is only provided to those, including third parties, who are in charge of or manage the recruitment and selection activities within BookerZzz or who are necessarily involved. The personal details are received by the HR department of BookerZzz. BookerZzz will not provide details of applicants to third parties unless they are legally obliged to do so.

We only share your personal data with third parties if we have a good reason for this. In accordance with our legal lighting under the "General Data Protection Regulation", we only work with parties that meet the requirements in the form of a processor agreement.

How long do you keep my personal data?

We keep your personal data for one year.

How do you protect my data?

We take the protection of your personal data very seriously. We take measures in the event of abuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.

How can I view, modify or delete my data?

You always have the right to view, modify or delete your personal data. You also have the right to withdraw any consent to the data processing or to object to the processing of your personal data by BookerZzz B.V. and you have the right to data portability.

In short: you can submit a request to us to see, correct, delete or transfer the personal data that we have about you. Or you can withdraw permission to use data.

- How do we verify that it is you?

In order to ensure that the request for access has been made by you, we ask you to send a copy of your proof of identity with the request. In this copy, make your passport photo, passport number, citizen service number (BSN) and MRZ (machine readable zone, the strip with numbers at the bottom of the passport black).

- When can I expect a response?

We will respond to your request within four weeks.

- Do you disagree with the processing of your data?

Then you can always complain to the national supervisory authority, the Dutch Data Protection Authority.
